- 1** Fire, Lightning, Explosion, Thunder Bolt, Subterranean fire, Riot, Strike, Civil commotion, Burglary Impact by road vehicles, or animals, aircraft damage, bursting or overflowing of water tanks, subsidence or landslip, earthquake, volcanic eruption, hurricane, windstorm, tornado, flood and malicious damage.
- 2** Loss or damage to helpers and visitors property-15% of Contents Sum Insured.
- 3** Additional expenses for alternate accommodation or loss of rent if your own home cannot be occupied due to damage. Limit - up to 10% of Sum Insured on building and contents.

- 4** Public authorities clause and debris removal.
- 5** Architects, engineers and surveyors fees.

- 6** Damage or theft of up to \$1,000.00 in cash.
- 7** Breakage of mirrors.
- 8** Loss or damage of personal property whilst in a hotel or home other than your own. Including lost passport, drivers license, travel tickets and other valuable documents – limit \$2,500.00
- 9** Medical Expenses – limit EC \$2,000.00.
- 10** Damage to underground utility lines - limit EC \$1,000.00.
- 11** Contents whilst temporarily removed from premises or whilst in transit-15% of Contents Sum Insured.
- 12** Up to \$10,000.00 for death of the insured caused by accident or thieves.
- 13** Personal accident coverage of up to \$10,000.00 whilst traveling as fare paying passenger by land, air or sea.
- 14** Cancellation cost for prepaid travel arrangements due to death, serious injury or extensive damage to your home.
- 15** Unspecified special possessions limit - 33% of Contents Sum Insured.
- 16** Pet coverage, medical expenses for accidental injury, up to \$250.00 – Replacement cost of pet up to \$1,000.00.
